

RGU Earn While You Learn Policy Document

In its endeavour to provide unique opportunities to all the students in attaining quality education and holistic development during their stay of learning; The Assam Royal Global University always strive to create platform, engaging and meaningful support so as the student learn to understand the value of time and effort involved. In line with the mission of providing an enabling environment to support bright students and giving them the opportunity to earn University has proposed to offer **“Earn While You Learn”** to the meritorious students at the University. This opportunity is with the students who wish to earn and have limited access to finance. Royal Global University offers Earn While You Learn Policy to qualified meritorious candidates, both domestic and international. This financial assistance is intended to support those candidates who have the desire and competency to excel in higher education but find it difficult to fully support their education expenditure.

To strengthen the commitment towards the University and the stakeholders at large, students are expected to sincerely work for 10 hrs./week during their non-teaching hours, in Admissions/ Front office/ Library/ Back office/ Kitchen Support/ Hospitality/ Facility Management/ Sports Department/ Security Support, etc. which may be notified to the student based on the requirement of the University from time to time.

Eligibility

Candidates seeking financial support through Earn While You Learn must provide evidence of financial need as per the eligibility criteria, and documentation listed below. They may be asked to submit additional information during the application review process. At the time of final selection by the University Committee, preference will be given to candidates residing in sub urban/rural area, living in PG accommodation in nearby area and one who has limited access to funds.

Specific Criteria for eligibility include but not limited to:

- Minimum 7 CGPA/ SGPA in the previous exam
- Annual family income not exceeding Rs 5,00,000

Terms & Conditions for Financial Support:

- Earn While You Learn is subject to verification and authentication of the relevant certificates / documents, as required by the University.
- A student is permitted to avail only one financial support/scholarship at a time.
- The students will be given Rs 250 /Hrs. up to maximum of 20 Hrs/ Rs 5000 per month that may be provided as honorarium.
- This financial support may be given to maximum 20 Students per Semester, which may be subject to change/ decision of the competent authority of the University.
- The dully filled application form with the supportive documents, for availing the financial support must be submitted to the University by last date specified in the notification issued by the competent authority. Applications received after due date will not be proceed further.
- Final decision regarding admissibility will be taken by the University and cannot be claimed as a matter of right by any eligible applicant.
- If at any stage, it is found that an applicant has concealed, suppressed, distorted any information/fact(s) which would have rendered him ineligible for admission and/or ineligible for benefit of financial support or applicant has been admitted and/or Support has been awarded by the University, then the admission and/or Support will stand cancelled, and University will take action for recovery from such students.
- The decision of the competent authority of the University shall be final and binding on all concerned.
